Purpose of Collection of Personal Information

While visiting GIS, User may be asked to voluntarily provide personal information in order to accomplish the purpose of User's visit. Onward Transfer

FRM is a US based company that conducts business in many different countries. If a User accesses GIS from different countries, User should expect that information will be processed in the United States. Use of this website constitutes User's consent for cross-border transfer of data.

Integrity, Protection, and Retention of Personal Information

Data Analytics and Cookies

FRM through GIS may collect indirectly through standard logs information such as IP address, what browser is being used (e.g., Safari), and the domain name from which a visitor entered the site (e.g., www.yourcompany.com or www.youruniversity.edu). FRM uses this information to administer and improve our site. Some data may be traceable to an individual, but FRM does not normally seek to identify individuals unless FRM believes someone is using our site improperly or illegally.

A cookie is a small file which asks permission to be placed on User's computer's hard drive. Once User's agree, the file is added and the cookie helps [analyseanalyze](#) web traffic or lets

User know when User visits a particular site. Cookies allow web applications to respond on a more individualized basis. GIS does not currently make use of cookies.
